

# **DATA PROTECTION**

### How to be compliant in your use of social media

- Think before you type don't say things that ought not to be shared
- Obtain consent for posting to social media (for children: from parent or guardian)
- Create a CLOSED group for your Scout communications
- Set strict rules for your Admins for granting permission to join (set some questions to answer)
- Disable the "Share" and "Save as" button on images
- Update privacy settings regularly
- Don't be friends with everyone who asks (make sure they are people you really know)



#### Some guidelines

- Children need particular protection when you are collecting and processing their
  personal data because they and their parents or carers may be less aware of the risks
  involved. This should always underpin your social media decision-making process.
   Think about the need to protect them from the outset, and design your systems and
  processes with this in mind
- Remember, though, that all our members, including adults, will be looking to us to
  protect their personal data from wrongful publication on social media. Everyone has the
  right to access their personal data; request rectification, object to processing and have
  their personal data erased
- You need to have a lawful basis for processing anyone's personal data including on social media. Consent is a lawful basis for processing. Obtain consent from whoever holds parental responsibility for a child.
- A specimen form of consent is attached to these guidelines, which can be used at the same time as other information is obtained relating to the member concerned. You can download a Word version to help with setting up the consent form on your computer
- Have clear privacy notices saying what will happen to personal data, and what rights they have

- Developing knowledge and understanding in key areas
- Ensure awareness of policies and procedures
- Raise awareness of individuals' roles and responsibilities
- Welcoming
- Communicating information

## What should you avoid with social media?

- Sharing personal information (addresses etc)
- Sharing details of where we meet
- Posting without consent
- Posting images without disabling the "save as" and "share" function
- Sharing any image or information that does not meet these guidelines and/or does not take account of customs and local sensibilities
